B) Declaration (rules, anti-doping, conduct)

1. Eligibility and acceptance of WRRRC rules. Annual coach registration is mandatory. By signing, I accept and agree to comply with the WRRRC Code of Conduct for WRRRC Athletes and Officials, WRRRC Competition Rules and related WRRRC regulations/decisions, as amended.

2. Anti-doping (Coach as Athlete Support Personnel). I am bound by applicable anti-doping rules (incl. WDSF Anti-Doping Code as applicable within WRRRC and the World Anti-Doping Code). I will not encourage, assist, cover up or facilitate the use of prohibited substances/methods, nor obstruct doping control/investigations. I will cooperate with competent authorities and disclose any prior anti-doping rule violation decision involving me within the last 10 years where required.

3. Code of conduct at competitions and events. I will act professionally and respectfully; I will not engage in discrimination, harassment, violence, threats or abusive behavior. I will follow event procedures, accreditation rules and decisions of appointed officials.

C) Data protection (GDPR) – information, lawful basis & rights

4. Data processing notice. WRRRC and/or the relevant National Federation (administrator) process my personal data for coach registration/status, eligibility checks, competition administration, integrity/safeguarding/disciplinary management and compliance with anti-doping/legal obligations. Processing is based on performance of the registration/participation arrangement and WRRRC legitimate interests; where required, on my consent. Data may be shared with WRRRC member NFs, organizers and competent anti-doping bodies, including possible international transfers with appropriate safeguards. Data are retained as necessary; I may exercise GDPR rights (access, rectification, restriction, objection, portability, deletion where applicable).
